

Guidelines to apply for American Rescue Plan Funds through the Jackson Arts Council funded by the National Endowment for the Arts

OVERVIEW:

The Jackson Arts Council will function as the pass-through organization for American Rescue Plan (ARP) funds provided by the National Endowment for the Arts. ARP funds available through this grant opportunity are to support eligible organizations and jobs in the arts sector that have been impacted by the Coronavirus pandemic. Eligible organizations must be located and artists must reside within the Jackson Arts Council's eight county region, including Chester, Decatur, Hardeman, Hardin, Haywood, Henderson, Madison, and McNairy Counties of Tennessee.

Applicants are required to complete an online application with all required materials listed in this guideline, and if awarded, sign an award contract stating compliance with award requirements.

As there are many interested applicants for this grant funding in our region, we strongly encourage all interested applicants to read these grant guidelines in full before contacting the Jackson Arts Council office with questions.

Application Deadline: May 15, 2022, 11:59 p.m. Central Time

AWARD:

One-time funds up, minimum \$500 maximum \$29,990, per applicant for the purpose of Coronavirus pandemic recovery.

No cash match is required. This award will be a reimbursement of expenses used within the funding period (July 1, 2022 – May 31, 2023).

Final determination of each award will be based on volume of eligible applications and available funds. While applicants may request the maximum award amount, final award may be less than requested. All awarded funds must be expended within the funding period (July 1, 2022 – May 31, 2023).

ELIGIBILITY:

Applicants for these funds must be one of the following:

- 501(c)(3) organizations in good standing with the IRS. Organizations without their own 501(c)(3) designation cannot apply.
- Units of state or local government
- Institutions of higher education
- Federally recognized Indian tribal governments
- Individual Artists

All applicants must meet a standard of artistic excellence and artist merit to be evaluated by an independent panel. The purpose of these funds is to support the arts sector. All applicants must provide a history of arts-based programming and/or projects and an intention to use funds for recovery of the arts sector to receive funding.

APPLICATION TIMELINE:

The timeline below is meant to get funding out as quickly as possible to eligible applicants. Please submit applications as soon as you are able as we will not accept late or incomplete applications.

Application Window: March 1 2022 – May 15, 2022 (12 weeks) Application Deadline: May 15, 2022, 11:59 p.m. Central Time

Review Period: May 15, 2022 – June 20, 2022

Grant Panel Review: June 22, 2022 (applicants encouraged to attend in person or via phone call)

Notification and Awards: Week of July 1, 2022 Signed Grant Award Contract Deadline: July 31, 2022

Funding Period: July 1, 2022 – May 31, 2023

ALLOWABLE COSTS:

Allowable costs differ for organizations and individual artists.

Organization allowable costs:

- Salary support (including benefits support if applicable) full or partial, for one or more staff positions.
- Fees/stipends for artists and/or contractual personnel to support the services they provide for specific activities in support of the subgrantee organization's day to day operations.
- Facilities costs such as rent and utilities.
- Costs associated with health and safety supplies for staff and/or visitors/audiences (e.g., personal
 protective equipment, cleaning supplies, hand sanitizer, etc.).
- Marketing and promotion costs.

Unallowable costs for organizations:

- "Artist relief" programs where funding is intended to alleviate financial hardship (i.e., rent or food assistance to individuals) and does not require the artist to undertake work.
- Alcoholic beverages
- Commercial (for-profit) enterprises or activities, including concessions, food, clothing, artwork, or other items for resale. This includes online or virtual sales/shops.
- General fundraising.
- General miscellaneous or contingency costs.
- Land purchase costs.

- Lobbying, including activities intended to influence the outcome of elections or influence government officials regarding pending legislation, either directly or through specific lobbying appeals to the public.
- Mortgage interest, fines and penalties, bad debt costs, or deficit reduction.
- Rental costs for home office workspace owned by individuals or entities affiliated with the applicant organization.
- Social activities such as receptions, parties, or galas.
- Subawards to replace lost revenue.
- Travel costs.
- Vehicles purchases.
- Visa costs paid to the U.S. government.
- Voter registration drives and related activities.
- Costs supported by any other federal funding. This includes federal funding received either
 directly from a federal agency or indirectly from a pass-through organization such as a state
 arts agency, regional arts organization, or a grant made to another entity.

Individual Artist allowable costs:

- Specific artistic project or activity that must be completed within the project period (July 1, 2022 May 31, 2023) that must meet standards of artistic excellence and artist merit to be evaluated by a panel.
 - o Ex: presentations, training, research, creation of artwork with tangible outcomes

Unallowable costs for individual artists:

- Onetime monetary recognition awards
- Honorific with no tangible project or activity
- Funds for artists under the age of 21

HOW TO APPLY:

- 1. Find all information about the grant on the Jackson Arts Council's website
- Review this Guidelines document and watch application tutorial video on the Jackson Arts Council's website
- 3. Review the Subaward Certifications on the Jackson Arts Council website to make sure you / your organization are able to implement the award in full accordance with the U.S. Constitution, federal Law, and public policy requirements.
- 4. If you / your organization are eligible to apply <u>after</u> reviewing these guidelines, watching the application tutorial video, and reviewing the Subaward Certifications, complete the online application here: https://forms.gle/3De2bVC5AzcQYKsx8

- 5. After reviewing your application, click "submit" at the end of the form. Do not submit unless you have completed the full application.

Applications will not be accepted after May 15, 2022, 11:59 p.m. Central Time

Application Accessibility:

If you are unable to complete your application due to accessibility need, limited technology, or inability to connect to the internet, you may contact the Jackson Arts Council office at 1-731-422-1385 between 9:00 a.m. -4:00 p.m. M-F to schedule a time to fill out the application over the phone with a staff member who will transcribe the application over the phone on behalf of the applicant. This request will need to be scheduled and completed no later than May 9^{th} , 2022, to give the staff member time to complete the application on behalf of the applicant.

REVIEW PROCESS

Applications will be reviewed for eligibility, completion, and artistic excellence and merit by a Grant Review Panel of community professionals and local artists.

While not required, your attendance at the panel review meeting on June 22nd is strongly encouraged.

Panelists may wish to direct specific questions to you regarding your project.

The following criteria of artistic excellence will be considered by the panel during application review:

Artistic excellence will be evaluated based on the material and work samples submitted with each
application that demonstrate mastery of skills and techniques, communication of unique vision or
perspective, professional approaches to process and presentation. For organizations, artistic
excellence should include the contribution of artistic works, or for arts services delivered, the
contribution the services make to the development of a vibrant arts and cultural community.

The following criteria of artistic merit will be considered by the panel during application review:

- New artistic impact on the community, such as:
 - o Strategies to bring new attention or elevating community assets, voices of residents, local history, or cultural infrastructure.
 - New ways of overcoming a community challenge or approaching community problem-solving.
 - Connecting communities, people, places, and economic opportunity through physical spaces or new relationships.
- History of artistic practice and/or programming.
- Potential of the organization or artist to reach underserved populations such as those whose opportunities to experience the arts are limited by geography, ethnicity, economics, or disability, and where applicable, the extent to which a program or project specifically addresses the issue of inclusion.
- Demonstrated commitment to serve their community through the arts throughout the pandemic.
- Demonstrated commitment to retaining the creative workforce in the region.

- -Demonstrated commitment to serve their community through the arts throughout the pandemic.
- -Demonstrated commitment to retaining the creative workforce in the region.

Unallowable costs for individual artists applying for these grant funds include:

- Honorific with no tangible project or activity

Artists under age 21 are not allowed to apply.

Individual artists MUST show proof of history of artistic excellence and artistic merit that will be evaluated by a qualified panel. Individual artists must also provide a detailed plan of project to be evaluated by the panel.

All individual artists who receive grant funding will be required to submit a W9 to the Jackson Arts Council and will receive a 1099 from the Jackson Arts Council for tax purposes.
